Financial Boot Camp Workshops Offered to Protect the Health of Small Businesses

A 4-part intensive online workshop series for small business owners

City of Whittier staff and leaders, including Mayor Joe Vinatieri and City Manager Brian Saeki, will reflect on City accomplishments from the past year, review the City Council's strategic goals and more at the annual State of the City Address presented by the Whittier Area Chamber of Commerce's Economic Development Committee.

This popular event, in partnership with Corporate Sponsors Athens Services, Brookfield Residential, DoubleTree Hotel Whittier, PIH Health and Southern California Edison and Community Partners Kaiser Permanente, MAP Property Management, Republic Services, Southern California Gas Company, and Suburban Water, will be held in person on Thursday, May 26 at 8:30 a.m. at the DoubleTree Hotel Whittier. Doors will open at 8:00 a.m. All businesses and residents are invited to attend this important business event and submit questions in advance or during the presentation. Tickets are \$25 per person and include breakfast and networking before and

after the presentation.

This year's Address will highlight the City Council's goals and objectives for the new fiscal year, as well as the City's budget, capital improvement projects, commercial development, business support, and public safety. 





Residential Burglary Prevention

Residential Burglaries. For the past two years, while many community members worked from home and most kids in our community attended school from home, we saw the lowest rate of residential burglaries in decades.

With life back to normal, residential burglars know that most homes are once again unoccupied during daytime hours, when most residential burglaries occur. With this in mind, here are some reminders to help reduce your chance of becoming a residential burglary victim:

- Lock all doors, windows and side gates when leaving your home, even for a guick errand.
- Arm your alarm system and ensure that an alarm sign on your property is clearly visible from the street. For apartments and condos, use an alarm sticker on the door or a nearby visible window.
- Make use of available video technology with a visible video camera or doorbell device.
- Get to know your neighbors, especially if they are home during the day, and ask them to report any suspicious activity on your property to the police department.
- Residential burglars are mainly after jewelry, cash, firearms, portable electronics, and designer fashion items. Make these items hard to find in your home.

Home burglars drive neighborhoods looking for easy targets. Make your home a hard target with alarm signage and visible video devices, locked access points and watchful neighbors.



After all the votes were counted from the District 2 election that took place on Tuesday, April 12, 2022, it was concluded that Octavio Cesar Martinez was the victor.

Martinez, a small-business owner, led Sullens, manager of a cardiology practice,1,256 to 1,101 during early returns. After 2,917 vote-by-mail ballots were counted Martinez extended his lead to 1,532, or 52.5%, to 1,334, or 45.7%.

Martinez said in a telephone interview that, "I will push for and work with and continue to bang the drum for a special prosecutor to prosecute our misdemeanor crimes."

"Whittier has a multi-million dollar budget so cost is not an issue. It's only impossible when you don't want to."

Octavio Martinez has been a resident of Whittier for over 35 years, where he and his wife Lilia, raised their three children. Octavio has been active as a community leader and is currently an appointed commissioner in Cultural Arts for the city.

He also advises leadership teams of small businesses, corporations, and other enterprises on leadership and team development. He has shared this knowledge with individuals and organizations throughout the United States, and around the world.

Locally, Octavio has served as a Volunteer Chaplain for both the Los Angeles Sheriff's Department and the Whittier Police Department. For over 8 years, Octavio was the leader of a local non-profit, advised local leaders to identify local needs, develop partnerships, and implement outreach initiatives with the hope of promoting quality of life for our community.

Octavio is ready to bring his experience and quality leadership to city hall where "safe streets, economic opportunities, and serving the needs of our community always come first."

7 Ways to Reduce Your Chance of Being Burglarized

There are several ways that you can help to reduce the chance of being burglarized. Most commercial burglaries are a crime of opportunity. In other words, a suspect sees an item of value within a closed business, rapidly gains access by smashing a door or window, and then quickly takes the property

and flees. This oftentimes happens within a matter of a few short moments.

The safety and security of our businesses is a high priority to the Whittier Police Department. Daily, our patrol officers remain highly visible and frequent businesses across the city to help deter theft and other criminal activity. In addition to our efforts, our business owners can partner with us and take the following measures to help reduce your business from being victimized while closed.

- Make sure all doors and windows are locked and secured
- An alarm is activated that covers doors, windows, and all access points
- Do not leave any items of value in plain sight that can be readily carried away
- Functioning security cameras should be prominently displayed at the business
- The exterior of the building including doors and windows should be well lit and visible
- Do not store any money in a cash register or another readily accessible location
- Post signage that the business is alarmed, monitored, and that no money is kept on site

Taking these precautionary steps can help to reduce the attractiveness of your business to a would-be burglar. Also, it is important that after hours contact information is on file and current with your alarm company and other stakeholders. Please continue to be vigilant by looking out for your business, and your neighboring businesses, and immediately report signs of suspicious persons or activity to the police department. Congresswoman Linda Sanchez secures funding for 3 Whittier projects

Congresswoman Linda T. Sánchez voted for the bipartisan Omnibus Appropriations Agreement, which the Senate passed in March. The Omnibus Appropriations Agreement provides \$1.5 trillion in discretionary resources and supplemental funding that will help working families with the cost of living and create American jobs. It includes \$219.6 million that the Congresswoman secured to fully fund upgrades to the Whittier Narrows Dam to completion and ensure the safety of residents of the City of Pico Rivera and downstream communities. Additionally, for the first time in over a decade, that package includes funding for Member-specific community projects.

"I am honored that we were able to include funding for nine projects requested by our gateway cities. Taxpayers deserve to have a say in where their money is spent. These projects will make life better for Southern Californians and I am proud to deliver the funding needed to complete each one," said Congresswoman Sanchez.

The following Whittier community projects were included in the Omnibus Appropriations Agreement:

- \$200,000 for the Boys and Girls Club of Whittier. The funding would be used to make modifications that improve accessibility, safety, and equity at the Boys & Girls Club Whittier's Main Clubhouse. The modifications would include a fully ADA-compliant elevator, accessible restrooms, ADA-van accessible parking, accessible pathways, and related equipment and labor.
- \$450,000 for the City of Whittier's Central Library Remodel and Improvement Project. The funding will be used for enhancement to the Children and Youth Services section in Whittier Central Library, including updated furnishings, additional seating, technology stations, a children's story area, and special computers for early learners.
- \$500,000 for The Whole Child Mental Health and Housing Services. The funding would be used toward construction of a 40-unit interim housing and 6,000 square foot supportive services center in Santa Fe Springs. Interim housing units would provide six to nine months of safe temporary housing, a crucial first step away from homelessness, and supportive services would be available to help families solve issues that caused their homelessness and to locate permanent housing.



CalChamber Releases 2022 Job Killer List

The California Chamber of Commerce released the first wave of bills to be included on its 2022 job killer list. The preliminary list includes 9 new bills and two carry-over proposals from 2021. CalChamber expects several additions to the list in the coming weeks.

"California companies are the economic engine that drives innovation and job creation in our state and are responsible for the record revenues the state is currently experiencing," said CalChamber President and CEO Jennifer Barrera. "Yet, the bills on this year's job killer list reflect a lack of appreciation of the economic realities and regulatory challenges employers—and especially small business employers—face as they continue to emerge from the impacts of this pandemic. A shrinking workforce coupled with California's oppressive legal climate, penchant for overregulation, and continued push for even higher taxes, will hamper the ability of California companies to remain competitive in the future. This year's job killer list highlights policies that will hurt job creation and will shut down or reduce investment in our economy."

The 2022 CalChamber Job Killer List includes the following bills:

Labor and Employment

AB 2095 (Kalra; D-San Jose) Unfair Denial of State Opportunities. Places new onerous administrative burdens on employers by requiring annual reporting of wage and hour data and employee benefits on an employer's entire United States workforce that will unfairly criticize employers for lawful conduct by publishing that data on the Labor and Workforce Development Agency's website and using such data to rank employers and deny them state opportunities and will subject employers to frivolous litigation and settlement demands.

AB 2182 (Wicks; D-Oakland) Expansion of Duty to Accommodate Employees and Litigation Under FEHA. Imposes new burdens on employers to accommodate any employee with family responsibilities, which will essentially include a new, uncapped protected leave for employees to request time off and exposes employers to costly litigation under the Fair Employment and Housing Act by asserting that any adverse employment action was in relation to the employee's family responsibilities, rather than a violation of employment policies.

SB 1044 (Durazo; D-Los Angeles) State of Emergency. Allows employees to leave work or refuse to show up to work if employee subjectively feels unsafe regardless of existing health and safety standards or whether employer has provided health and safety protections and subjects employers to costly Private Attorneys General Act (PAGA) lawsuits if they dispute the employee's decision or need to have another employee take over any job duties.

SB 1162 (Limón; D-Goleta) Publication of Pay Data. Encourages litigation against employers based on the publication of broad, unreliable data collected by the state. Undermines employers' ability to hire, imposes

administrative and record keeping requirements that are impossible to implement, and subjects employers to a private right of action and penalties under the Private Attorneys General Act (PAGA).

Taxation

AB 2289/ ACA 8 (Lee; D-San Jose) Wealth Tax. Seeks to impose a massive tax increase upon all forms of personal property or wealth despite California already having the highest income tax in the country. This tax increase will drive high-income earners and job creators out of the State as well as the revenue they contribute to the General Fund.

AB 1771 (Ward; D-San Diego) Targeted Tax on Certain Home Sellers. Seeks to impose a tax—in addition to the capital gains tax—of 25% on the profits from a home resold within three years after it is purchased. The tax rate is reduced on a sliding scale for seven years thereafter. This will worsen housing unaffordability and constrain the already limited housing supply.

SB 1301 (Becker; D-Menlo Park) Fossil Fuel Investment Surcharge. Arbitrarily raises taxes on companies that invest in fossil fuel businesses based upon the financing amount. This adds another layer of expenses onto the fossil fuel industry that will significantly increase the costs of doing business, thereby increasing prices paid by consumers for goods and services in California.

CEQA

AB 1001 (Garcia, Cristina; D-Los Angeles) Expands CEQA and Hurts Housing. Creates new highly subjective, non-quantifiable and litigation-bait standards in CEQA that will threaten California's economic recovery and ability to construct much needed

housing. It also removes local government discretion regarding how to analyze and mitigate proposed project impacts, thereby making projects more expensive, harder to build and more likely to be thrown into courts by NIMBY opposition. 2021 carry-over bill.

Privacy and Cybersecurity

SB 1189 (Wieckowski; D-Fremont) New Private Right of Action for Biometric Information. Creates legal liability for businesses large and small, potentially in the millions to tens of millions of dollars, while not providing any exceptions, such as for the use of biometric data for safety, security, or other reasonable purposes. Also imposes new, untenable restrictions on the use and disclosure of biometric information in a thinly veiled attempt to undermine the California Privacy Rights Act (CPRA) limited private right of action for data breaches.

Workers' Compensation

SB 213 (Cortese; D-San Jose) Workers' Compensation Presumption: Hospital Employees. Expands Costly Presumption of Injury. Significantly increases workers' compensation costs for public and private hospitals by presuming certain diseases and injuries are caused by the workplace and establishes an extremely concerning precedent for expanding presumptions into the private sector. 2021 carry-over bill.

Agriculture, Food and Natural Resources

AB 2764 (Nazarian; D-Van Nuys) Livestock Ban. Bans new or expanded commercial animal feeding and processing operations for meat, poultry, eggs, and dairy. Will increase food prices for Californians and force food to be imported from out of state to meet consumer demand.







TWC's Interim Housing Facility & Supportive Service Center in Santa Fe Springs

The Whole Child Celebrates Full **Entitlements and Funding of Interim Housing project for Homeless Families**

The Whole Child is celebrating the recently completed entitlements and funding for their upcoming project in Santa Fe Springs. Located at Lakeland Rd. and Laurel Ave., the overall project, "From Homeless to Homeowner," is a first of its kind in California and will be developed over five acres of land offering interim, permanent supportive and ownership housing opportunities for low-income and vulnerable seniors and families, and homeless families with children.

The Interim Housing component of the development has received support from across the spectrum, with Supervisor Janice Hahn of the 4th District being its most ardent champion from inception, providing seed funding of \$4.8 million to the project. Supervisor Hahn states, "This is an important project that will not only provide safe temporary homes for families with children experiencing homelessness, but will also provide these families with some stability and the support they need to get back on their feet. This is going to fill a gap in our system in the Southeastern region of LA County and I am proud to support The Whole Child's effort here."

The Interim Housing facility will be a three-story building fully developed and managed by The Whole Child. The site could provide interim housing to up to 40 homeless families at any time and is expected to serve over 150 families per year. It will feature a robust supportive services center with consultation rooms, family room, teen area, computer lab, playground and

pantry, among other amenities.

The City of Santa Fe Springs provided the land and \$1.1 million funding. Congresswoman Linda Sanchez recently allocated \$500,000 to The Whole Child's Interim Housing project. Governor Gavin Newson also announced awardees of the Homekey2 program, including an allocation of \$5.6 million toward The Whole Child's project; in the announcement he said, "We are continuing to act with urgency to fund quality Homekey projects, because that's exactly what the moment demands - swift, decisive action to assist the most vulnerable Californians." The Whole Child's Homeless to Homeowner project has received \$2.7 million in philanthropic funding.

With entitlements and funding completed, the project will break ground in June 2022.


